### **INTRODUCTION TO DASR 66**

#### **Course Code**

216011

#### **Course Duration**

Approximately 4 hours, conducted over 2 weeks

#### **Course Content**

This course provides detailed knowledge of maintenance licencing concepts, and an overview of the DASR 66 regulations and their implementation.

The course is primarily self-paced learning through ADELE, with a 1 hour live discussion with DASA staff.

Personnel working in DASA, personnel working in regulated continuing airworthiness organisations (CAMO, AMO, MTO) (including MAML holders) and personnel responsible for management of MAML holders.
