



## **DASR RELEASE 28 MAR 19 – TOP LEVEL CHANGES**

The first DASR release of 2019 was published on to the [DASA webpage](#) on 28 Mar 19. There were no major changes in this release, however the following are the key minor changes:

### **DASR M**

1. The following minor changes in the form of GMs and an AMC were incorporated into the DASR:
  - a. Removal of requirement for DASR Form 2 submission for changes in Airworthiness Review Staff under GM.M.A.713(a)5.
  - b. Removal of requirement for Occurrence Reporting in the Command Clearance process under AMC.M.A.301.
  - c. A GM was added to clarify the flexibility that a CAMO has with respect to the monitoring of contracted/tasked DASR M subpart G activities in.M.A712(b).

### **DASR 145**

2. Several minor changes were incorporated under 145.A.30 - Personnel Requirements, in order to correct the AMC and GM for specialist maintenance activities of Non-Destructive Testing (NDT) and composite repair.

### **DASR 21**

3. A minor change was incorporated under GM 21.A.41 - Type-Certificate and Restricted Type-Certificate, in order to provide additional guidance relating to propulsion systems and their relationship to the MTC.

## **DASR 66**

4. A minor change was incorporated under Appendix III – Standard of Existing Types Courses, to include the requirement of Maintenance Training Organisations (MTO) to assess their current Type Course against Appendix III then identify shortfalls and determine remediation action. This aligns with Defence training policy and procedures as well as DASR 147 requirement for continual improvement.

## **DASR AIRCREW**

5. A minor change was incorporated under GM AIRCREW.10.a(1) – The Award of a Category, in order to reflect a strategic initiative to assure compliance with the WHS Act 2011 and to demonstrate that DASA, represented by the MAO-AM as a Delegate of the Safety Authority, is responsible for the awarding of aircrew licenses.

## **GENERAL ADMIN**

6. In addition to the above minor changes, numerous editorial changes were made to the DASR. Please see online DASR for details.

## **DASR AMENDMENT MANAGEMENT**

8. In line with the 28 Mar 19 DASR release, the DASA website has been updated to allow access to the current DASR amendment and previous ('Historical') amendments. This functionality provides a record of the evolution of the DASRs, and also facilitates identification of changes within the DASR via comparison between the current and superseded versions. DPEPS-DASA will continue to explore options to better identify amendments, prior to the Sep 19 DASR release.
